Victim then stated that the suspect works for the Ft Lauderdale Police Dept and had taken his service revolver in the bedroom and told her not to come in. At this point the victim attempted to call the Police. The victim then advised that the suspect exited the bedroom with his service revolver pointed directly at her. The victim then ran out of the house for the fear of her life.		
S	Pond Richard stated to this deputy that he had been out drinking and when he came home at 0600 hrs he found his fiancee in bed with another female. The suspect further stated that he started to gather his belongings and was going to leave the house. The suspect told this deputy that he had taken his gun belt with his service revolver which was in a holster and walked in the bedroom and told the victim not to enter. The suspect then walked out of the bedroom with his gun belt and service revolver which again told this deputy that his gun was holstered and was going to leave. At this point the suspect stated that the victim was on the phone with the police and when he came out of the bedroom she dropped the phone and ran out of the house. The suspect then advised me that he picked the phone up and told the dispatcher that everything was ok. This deputy stood by for the suspect
