	<p>At 0333 Hrs, this deputy was dispatched to in reference to an accidental shooting which was reported via 911. Upon arrival this deputy made contact with the victim, Jamie Davis, and the suspect, Richard Pond in the kitchen. V-Davis was sitting on the floor holding her left wrist. This deputy observed blood pools around the victim and leading into the master bed room. This deputy assisted the victim by applying a pressure bandage. At approximately 0337 Hrs, Lauderdale Lakes Para Medic arrived on the scene. Med 42. While the victim was being treated, this S deputy interviewed S-Pond who related the following course of events: S-Pond stated that V-Davis was laying on the floor by the sliding glass window in the master bedroom. S-Pond stated he reached under the bed (on the far side from the victim) and removed the victim's revolver from underneath. S-Pond stated as he pulled the revolver out it accidentally discharged striking V-Davis in the wrist. S-Pond stated he did not know what he did with the gun only that he went to V-Davis to assist her and then called the Sheriff's Office via 911.</p>

V	incident: V-Davis stated that she was sitting on the bed when S-Pond took the revolver from underneath the bed and was explaining some sort of police work when the gun went off. This deputy inquired to the black eye and swollen lip which she had. The victim stated that those injuries must of happened when she drew her hand to her face. V-Davis did state that she had had an earlier verbal altercation with the suspect but that there was no physical contact. The victim insisted that the incident was an accident and that she would not press any charges. The victim signed a waiver of prosecution witnessed by this deputy.		
DW	This deputy must also note that at one point S-Pond stated, "I didn't mean to shoot her; it was an accident. If I wanted to kill her, I could have."		
DW	This deputy discovered the weapon used, Smith & Wesson Mod. 19 Blued 4", .357 Magnum revolver Ser. # 38K5390 with 1 spent S&W 38 spl, 2 live S&W 38 spl, 3 RP .357 magnum live rounds in the Master Bedroom just to the right of the head board by the wall. The weapon was released at the scene to Detective Falley of the Forensic unit.

	At approximately 04:30 hours, this writer arrived at the above location, which is a residential home, of cement block structure located on the south side of _____ Lauderdale Lakes. Deputy Bunghan, and Sgt. Robert Baton of the Lauderdale Lakes district were protecting the scene.		
	Deputy Bunghan related that at approximately 03:30 hours, he was dispatched to the above location reference an accidental shooting which was reported via the 911 emergency system. Upon his arrival, he made contact with the victim Jamie Davis, a white female (DOB 7/22/54), who resides at the above location, and the suspect, a Richard A. Pond white male (DOB 3/25/52). Note that at this point, this writer knows suspect, Pond as being an ex-employee of the Ft. Lauderdale Police Department.		
	Deputy Bunghan related that the victim Davis, was sitting on the floor of the kitchen holding her left wrist, which was observed to be blood covered, there was pool of blood around the victim and the floor of the kitchen and upon his examination, the blood lead into the master bedroom which is located on the west side of the residence. The suspect was also in the kitchen trying to render first aide to the victim. While EMS personnel treated the victim, and then later transported the victim to Broward General Hospital, Deputy Bunghan interviewed suspect Pond who related that the victim was lying on the floor by the sliding glass doors, which were located on the northwest side of the house, and he related that he went and got the victim's gun which was usually kept under neath the bed in the bedroom and as he got the gun, out from underneath the bed, the bun went off striking the victim in the left wrist. Suspect Pond related that it was an accidental shooting and that if he wanted to kill victim he would have done so. It is noted that the this point, that deputies responded to this house on several occasions of domestic complaints.		
	Deputy Bunghan related to this writer that he had discovered the weapon used (Smith and Wesson Model 19 Blue finish 4" barrel length), .357 magnum revolver, SN: 38K5390.


